Dear Parent/Guardian,

We need your help in finalizing our basic plan for this year's religious education program. Because the pandemic, numbers and response change regularly, we are currently basing our plan on the Carbon School District and Southeastern Utah Health Department guidelines.

Students and all adults in the building would be required to wear masks while in the classrooms, hallways and other areas of the building.

Currently we are planning on holding classes on Tuesday evenings from 5:45 – 7:00 p.m. for Grades 1-6. There will be no on-site Pre/K classes offered this year, but we will have packets available for those interested in teaching at home. There will be a 7th grade class offered on Wednesday evenings from 5:30-6:30 PM. Based on last year's attendance numbers, we would have students attend on alternating weeks in order to maintain 6 foot social distancing. If the number of students that register to attend in person is low enough to provide space for social distancing, we will hold classes each week. If you choose not to send your child to classes, we will have materials for you to teach your child at home. Myself or a teacher will check in with you on a regular basis to see if you need additional materials and to check on your child's progress.

Because 2nd grade is a sacrament year, and 1st grade is a sacrament prep year, all students would be asked to attend classes in person. If there is a medical problem, or another issue, we will meet with the parents and come up with a plan to address the issue. The student would have to meet with myself or a teacher on a regular basis to make sure that the lessons are being completed in a timely manner and that the student is learning the necessary information.


Though we cannot hold family activities in person, we are planning on sending home family activity packets several times this year.

Please return the bottom portion of this letter and registration form **with a contact email** back to the parish office by next Tuesday, August 25. The number of students who are planning to attend classes in person will determine the plan for this year. You may mail it, drop it in the collection basket at church, place it in the mailbox outside of the center, scan and email it to notredamechurchprice@gmail.com or call 637-1846 and speak with Catherine. Decisions will need to be made on how to make classes work for this year. Confirmation will begin on Sunday, September 13. Our target start date for Religious Education is Tuesday, September 15. The fees for religious education will remain the same. We ask \$40 for the first student and \$20 for each additional student up to an \$80 total for families. No child will be denied religious education if you are not able to pay the fees.
